Payment Information for vacant churches

- Two separate payments are to be made as per the following information:
 Classical Appointment Fee of \$200.00 is to be made payable directly to the supplying church.
 Mileage Allowance of \$0.58/kilometre is to be made payable directly to the supply pastor.

Classical Appointment Information

- Classical appointments will be provided twice per month when the Classis has four or fewer vacant churches.
- When there are five or more vacant churches classical appointments will be provided once per month.
- Distances to churches (mileage costs), special event Sundays, holidays, denomination and classis events, time between assignments have all been taken into consideration when determining dates and where pastors have been assigned.

Change in Appointment Schedules

- Any changes being made to the schedule including changes due to COVID are arranged between the church and the pastor.
Vacant church please note: The supplying church needs to make alternate arrangements to hire a minister for their church when their pastor is away on a classical appointment; to avoid any inconveniences please ensure you have provided adequate notice to the pastor if you are not in need of a classical appointment (cancellation).
- The direction provided by CMC with regards to classical appointment fees is as follows:

"During the time while churches are not meeting in person when a pre-recorded sermon is provided to the vacant church by the supplying pastor there would be no fee paid to the supplying church. Classical appointment fees are only paid when a pastor travels to the vacant church to provide the message.

Exception: If a special request is made to the pastor by the vacant church whereby the pastor is asked to provide a newly written and recorded sermon specifically for that church for a service, a classical appointment fee will then need to be paid to the supplying church."

- Pastors are free to exchange with one another and/or rearrange dates with the vacant church, but it is expected that all appointments will be kept.
- It is the responsibility of the vacant church to confirm appointments with the minister and to forward relevant information (ie - times and locations of services, Lord's Supper, etc.). Pastors, please check with the vacant church in advance about any expectations for the planning of the worship.
- When a church is no longer vacant or council decides that you no longer require classical appointments, please inform the Clerk of Classis immediately statedclerkquinte@gmail.com
